# Anti Ragging and Eve teasing committee report from 2016-21

As per UGC Regulations 2009 as well as under the provisions of any penal law for the time being in force Shree Chandrprabhu Jain College, Minjur, started the Antiragging and Eve Teasing Committee since 2011.

Anti-ragging committee is formed every year to prevent ragging related issues inside and outside the college campus. "Prevention is better than cure" so here are several basic guidelines followed by our institutions in order to prevent ragging from its root in our college campus

Counseling cell: our college has a counseling cell with a friendliest staff on the board as a cousellors. They will help the students to open up and talk about their problems during ragging and eve teasing The counseling cell is mainly focusing to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student. For this the college is place the banner in front of the main gate and a separate board and complaint box near the administrative office when and whom the fresher has to turn for help and guidance various purposes (which includes the Head of the institution, College Secretary, members of the anti ragging committee, relevant authorities, student representatives their address and phone numbers of such persons. A separate complaint box is placed near principal room.

Every year, Action Taken Report related to prevention of ragging and implementation of UGC antiragging guidelines are sent to the Registrar.

# Roles and Responsibilities:

- To be vigilant at all hours all around the campus and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
- To make surprise raids on railway station, canteen, and other places vulnerable to incidents and having the potential for ragging.
- To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian, as the case may be: and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
- To ensure the display of posters on Institution and Department Notice Boards and other prominent designated places.

• To offer services of counseling and create awareness to the students.

# Punishments for Ragging

Every single incident of ragging, a FIR shall be lodged without exception by the college authorities with the local police. In addition one or any combination of the following punishments can be awarded:

- Cancellation of admission
- Suspension from attending classes
- Withholding / withdrawing scholarship / fellowship and other benefits
- Debarring from appearing in any test / examination or other evaluation process
- Rustication from the institution for period ranging from 1 to 6 semesters
- Expulsion from the institution and consequent debarring from admission to any other institution
- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
