Mr.D.Karthickrajan a student of II BCA, 13SAZ06 was placed under suspension from the college for the alleged complaint of Eve teasing on 11.12.14. An enquiry committee which was constituted to enquire and report the fact submitted a report after enquiry that

- 1. The women students submitted a second petition in which they have stated that D-Karthickrajan was present at the scene but did not use abusive words.
- 2. In their witness also they have testified the same thing.

The enquiry committee while absolving D.Karthickrajan from the above offence, pointed out the following 5 irregularities on his part on the day of incident (11.12.14):

- 1. He has not informed about his absence on 11.12.14 from 3rd hour to any of the staff member or HOD in his dept.
- 2. He was rather roaming inside the campus and assembled the students at the vehicle parking area which is a prohibited part for the students to gather.
- 3. He was found using cell phones inside the campus at the time of the incident.
- 4. While he was present even though he did not indulge in the crime he did not to take any effective steps to prevent the students from eve teasing.

Therefore the enquiry committee recommended that as a habitual offender, the undertaking from him as well as his parents must be obtained, before revoking the punishment. Hence D.Karthickrajan was directed to appear with his parents before the principal within 7 days time.

On 09.01.2015, D.Karthickrajan, has appeared before the Principal with his father's brother. Since his brother was involved in an accident and his parents are attending him, his father's brother appeared and both of them submitted a letter to the Principal. The student expressed his apology and undertook not to repeat any mistake again and if repeated, he may be sent out of the college without enquiry.

When the apology letter along with the punishment given was placed before the HODs Meeting (college council) the members felt that D.Karthickrajan has already suffered a suspension in the case of misbehaving with Mr.Anandakumar, AP of ECS Dept. Then also he submitted a letter of apology and undertaking that he could be removed if he repeats the act of indiscipline again.

found that the students have concealed many facts of the involvement of girl students for the enmity between the III B.Com. 'B' and I B.Com. 'B' students considering the fact that resorting to violence on another students inside the class room, inside the staff room, before the gathering of students and before the teachers is considered to be a higher degree of violation of discipline done by the above students. However, the parents who were present for their enquiry have pleaded for mercy and have given an undertaking for their proper conduct of the students and considering the final year degree class in their career, the Principal accepts the undertaking and allowed the students to attend the class from 05.08.15. The above 2 students are strictly warned that in the event of their involvement in any sort of discipline they will be immediately terminated from the college without calling for any explanation.

- 3. V.Manigandan is found to be a habitual offender and a ruffian who got admitted in the I Year.

 He is arrogant and he is instrumental for all the problems. He has committed a following mistakes:
 - 1. Unnecessarily visiting the III year class on the pretext of meeting his sister.
 - 2. Unnecessarily comment on the senior girl students of the III B.Com. class
 - 3. Unwanted frictions with the III year senior students.
 - 4. He has invited outside elements to interfere in the college may through cell phone and personal call.
- 4. Particularly on 22.07.15 he has wantedly visited the III year class and provoked the two III year students which result in the clash, so he invited all the problems because of his incorrigible nature. The Enquiry Committee felt that the presence of this sort of students will certainly spoil the peace and tranquility of the college. For the mistakes committed by the student he has to be sent out of the college. However, taking a compassionate view about the future of the students and the undertaking submitted by the Mother of the student who is come all the days of enquiry, it is decided that the student be permitted to attend the college. But for the mistakes committed he has to undergo a long spell of suspension and therefore he may be permitted to attend the classes from 10th Aug. 2015, along with his mother he has to execute an undertaking that if he is involved in any problem in future whether inside the class or outside the class he will be terminated from the college.
- 5. It is also resolved to invite the parents of certain girl students of III B.Com. 'B' class, so that the parents may be informed of the ongoing of their ward in the college. It is also decided that all the women students in the III B.com. 'B' class in the first instants and all the class in the second instants may be given with a counselling by the Women Couselling Cell.
